1. SCOPE OF WORK:

Supply of air curtains at Central Products Dairy, Punnapra P.O, Alappuzha.

2. TERMS AND CONDITIONS:

1. The specification for each item of supply and schedule of quantities are given in the enclosed Annexure-1.
2. **The rate quoted shall be inclusive of all applicable taxes and duties, packing cost, transportation of materials to dairy and nothing extra will be paid on any account. The unloading will be carried out from dairy.**
3. The unit rates should be quoted both in figures as well as in words. In case of discrepancy in the rate quoted in figures as well as in words, the amount quoted in words shall be taken as final and binding on the party.
4. Based on the unit rates quoted, the total amount for each item of supply should be worked out and indicated in the offer. The unit rate quoted should be legible without any erasion /overwriting. In case of any correction and alterations in the unit rates at the time of quoting the same should be signed in full by the quotationer.
5. Quantities indicated in the schedule are only tentative and may vary to the +/- side. However, payment will be made for the actual quantities supplied at site as per the directions of Officer in charge, on unit rate basis. No extra claim shall be entertained on this account.
6. The award of contract shall be on item rate contract basis and no part of the contract shall be considered on percentage or lump sum basis unless specifically agreed by the undersigned.
7. The unit rate quoted should remain firm for the entire duration of contract and nothing extra will be paid on any account.
8. The bidder shall quote the rates in the schedule of quantities attached with the tender document only. The bids shall be submitted after signing at the bottom of every page of tender document.

3. VALIDITY:

The offers submitted by the quotationer shall remain valid for acceptance for a period of 60 days from the date of opening.

4. PERIOD OF COMPLETION:

At the items specified in the scope of supply should be completed in all respects within 20 days from the date of receipt of supply order. However, the quotationer after examining the scope of supply and site

conditions can specify in the offer the shortest period by which he will complete the supply of items in all respects.

5. SUBMISSION OF BILLS AND PAYMENT:

1. Bills shall be prepared in duplicate in the name of the Kerala Co-Operative Milk Marketing Federation Ltd, Central Products Dairy, Punnapra P.O, Alappuzha GST: 32AAAAK5375M4ZD and shall be submitted along with the copy of the GST registration, PAN card to the Engineer for necessary certification and recommendation for payment.
2. Payment will be released within 15 days after receipt of items in good condition without any damage in Central Products Dairy, Punnapra, Alappuzha, Kerala.

6. SUBMISSION OF QUOTATIONS AND OPENING:

1. The offer must be submitted in original in a sealed cover super scribing the name of the work, due date and time of opening.
2. Bidder should attach this tender document with rates written in the annexure attached along with this tender document, after signing at the bottom of each page of tender document as a token of acceptance of the terms and conditions and specification. The offers submitted in any other formats will not be accepted.
3. The offers complete in all respects should reach this office on or before 1 PM on 16/04/2025 and the same shall be opened at 3 PM on 16/04/2025 in the presence of interested quotationer or their authorized representatives.
4. The bids received after the tender submission date and time will not be accepted. Dairy will not be responsible for any delay in receiving the bids sent through post/courier.

7. GUARANTEE:

1. The supplier shall provide warranty for the items supplied in part or full if found defective due to bad workmanship or substandard materials within 12 months from the date of supply in dairy. The entire expenditure towards replacement / repair shall be borne by the supplier.
