## **I. GENERAL TERMS & CONDITIONS FOR E-PROCUREMENT**

This tender is an e-Tender and is being published online for carrying out the **Production, Packing and Supply of "READY TO DRINK PALADA" with Extended Shelf life** to MILMA Central Products Dairy, KCMF Limited, Punnappra P.O., Alappuzha, Kerala - 688004, during the period from 1st July 2026 to 31<sup>st</sup> July 2028. The tender is invited in two cover system from eligible individuals and registered firms through e-procurement portal of Government of Kerala (<https://www.etenders.kerala.gov.in>). Prospective bidders willing to participate in this tender shall necessarily register themselves with above mentioned e-procurement portal.

The tender timeline is available in the critical date section of this tender published in [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in).

### **A). Online Bidder registration process:**

Bidders should have a Class III Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on [www.cca.gov.in](http://www.cca.gov.in). Once the DSC is obtained, bidders have to register on [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

### **B). Online Tender Process:**

The tender process shall consist of the following stages:

- i. **Downloading of tender document:** Tender document will be available for free download on [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- ii. **Publishing of Corrigendum:** All corrigendum shall be published on [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) and shall not be available elsewhere.
- iii. **Bid submission:** Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document on [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- iv. **Opening of Bids:** Bids shall be opened and evaluated on the date and time mentioned in critical date's section of the bid document.

### **C). Documents Comprising Bid:**

#### **1. The First Stage (Pre-Qualification or Technical Cover based on 1 cover or 2 cover tender system):**

Pre-Qualification or Technical proposal shall contain the scanned copies of the documents that every bidder has to upload which are mentioned in clause no. 1 of General terms and conditions.

#### **2. The Second Stage (*Financial Cover or as per tender cover system*):**

The Bidder shall complete the Price bid as per format given for download along with this tender.

**Note:** The blank price bid should be downloaded and saved on bidder's computer without changing file-name; otherwise price bid will not get uploaded. The bidder should fill in details in the same file and upload the same back to the website.

**Fixed price:** Prices quoted by the Bidder shall be fixed during the entire period of the contract and not subject to variation on any account after finalization of the contract. A bid submitted with an adjustable/ variable price quotation will be treated as non - responsive and will be rejected.

### **D).Tender Document Fees and Earnest Money Deposit (EMD)**

The Bidder shall pay, a tender document fees of Rs. 5000/- (Rupees Five Thousand Only) and Earnest Money Deposit (EMD) or Bid Security of Rs.50,000/- (Rupees Fifty Thousand Only). The Bid security is required to protect the purchaser against risk of Bidder's conduct, which would warrant the forfeiture of bid security.

**Online Payment modes:** The tender document fees and EMD can be paid in the following manner through e-Payment facility provided by the e-Procurement system:

- i. **State Bank of India (SBI) Internet Banking**: If a bidder has a SBI internet banking account, then, during the online bid submission process, bidder shall select SBI option and then select Internet banking option. The e-Procurement system will re-direct the bidder to SBI's internet banking page where he can enter his internet banking credentials and transfer the tender document and EMD amount.
- ii. **National Electronic Fund Transfer (NEFT)** If a bidder holds bank account in a different bank, then, during the online bid submission process, bidder shall select NEFT option. An online remittance form would be generated, which the bidder can use for transferring amount through NEFT either by using internet banking of his bank or visiting nearest branch of his bank. After obtaining the successful transaction receipt no., the bidder has to update the same in e-Procurement system

for completing the process of bid submission. Bidder should only use the details given in the Remittance form for making a NEFT payment otherwise payment would result in failure in e-Procurement system. **As NEFT payment status confirmation is not received by e-Procurement system on a real-time basis, bidders are advised to exercise NEFT mode of payment option at least 48 hours prior to the last date and time of bid submission to avoid any payment issues.**

NEFT payment should be done according to following guidelines:

- a) **Single transaction for remitting Tender document fee and EMD:** Bidder should ensure that tender document fees and EMD are remitted as one single transaction.
- b) **Account number as per Remittance Form only:** Account no. entered during NEFT remittance at any bank counter or during adding beneficiary account in Internet banking site should be the same as it appears in the remittance form generated for that particular bid by the e-Procurement system. Bidder should ensure that tender document fees and EMD are remitted only to the account number given in the Remittance form provided by e-Procurement system for that particular tender. Bidders must ensure that the banker inputs the Account Number (which is case sensitive) as displayed in the Remittance form. No additional information like bidder name, company name, etc. shall be entered in the account no. column along with account no. for NEFT remittance.
- c) **Only NEFT Remittance Allowed:** RTGS payments, Account to Account transfers, State Bank Group Transfers (GRPT) or Cash payments are not allowed and are treated as invalid mode of payments. Bidder must ensure that the banker does NEFT transaction only irrespective of the amount and specially instruct the banks not to convert the payment type to RTGS or GRPT.
- d) **Amount as per Remittance form:** Bidder should ensure that the amount being remitted is neither less nor higher than the amount shown in remittance form.
- e) **UTR Number:** Bidders should ensure that the remittance confirmation (UTR number) received after NEFT transfer should be updated as it is, in the e-Procurement system for tracking the payment.
- f) **One Remittance Form per Bidder and per Bid:** The remittance form provided by e-Procurement system shall be valid for that particular bidder and bid and should not be re-used for any other tender or bid or by any other bidder.

Any transaction charges levied while using any of the above modes of online payment has to be borne by the bidder. The supplier/contractor's bid will be evaluated only if payment status against bidder is showing "Success" during bid opening.

## **II. GENERAL TERMS & CONDITIONS OF THIS BID DOCUMENT**

The Kerala Cooperative Milk Marketing Federation Limited (KCMMF) invites e-tender from eligible competitive bidders in the field of Manufacturing, Packing and Supply of "Ready to Eat" or "Ready to Cook" food segment in India for carrying out the **Production, Packing and Supply of "READY TO DRINK PALADA" with Extended Shelf life** to MILMA Central Products Dairy, Punnappra P.O., Alappuzha, Kerala – 688004, during the period from 1<sup>st</sup> July 2026 to 31<sup>st</sup> July 2028 as per the schedule and subject to the terms and conditions stipulated in tender document.

### **1. ELIGIBILITY CRITERIA: DOCUMENTS & INFRASTRUCTURE REQUIREMENTS**

To be eligible for the award of Contract, bidders shall provide satisfactory evidence to the Kerala Cooperative Milk Marketing Federation Limited the following informations.

**1.1** Copy of PAN CARD

**1.2** Address Proof in case of Individual - Aadhar Card/Election Identity Card/Driving License/ Indian Passport.

**1.3** Address Proof in Case of Proprietorship/Partnership firm or any institution/ company registered under Companies act – Copy of

registration certificate issued by any competitive authorities of State/Central Government.

- 1.4 Contact Details and Email address authenticated by the bidder (signed by the competent authority/Person)
- 1.5 Copy of certificate of GST registration
- 1.6 The bidder shall have their own manufacturing facilities with the State of the Art Technology in Ready to Eat Food production segment and the proof of the same shall be uploaded.
- 1.7 The institution/ organisation/company should have the new generation Sterilization Technique Microwave Assisted Thermal Sterilization (MATS) Technology that provide extended shelf life to the product. The details of such techniques currently being used shall be provided.

## 2. **SCOPE OF WORK**

**Production, Packing and Supply of "READY TO DRINK PALADA" with extended shelf life** to MILMA Central Products Dairy, KCMMF Limited, Punnappa P.O., Alappuzha, Kerala - 688004, which is a dairy working under Kerala Cooperative Milk Marketing Federation Limited, for a period of 2 years from 1<sup>st</sup> July 2026 to 31<sup>st</sup> July 2028, without any interruption includes in the scope of work.

## 3. **SPECIFIC TERMS & CONDITIONS**

- 3.1 **Contract Period:** The period of contract shall be for two years from **1<sup>st</sup> July 2026 to 31<sup>st</sup> July 2028**
- 3.2 Bidder should have well equipped and hygienic manufacturing facilities to manufacture and supply the items.
- 3.3 Items should be hygienically produced using standard manufacturing facilities and techniques as per ISO 22000:2018 requirements or equivalent or higher international standards
- 3.4 The KCMMF reserves the right to extend the supply contract for further two years at the same rate and terms if required and mutually agreed.
- 3.5 **Packing configuration:** The packing configuration of **"Ready to Drink Palada"** with extended shelf life shall be in Standing Pouch with net weight of 400 grams.

### 3.6 Packing material:

The primary packing shall be in standing pouches and the bottom portion shall be transparent to make the product visible. The packing material shall be good enough to use sterilization process and the pouches with a maximum weight variation of 400+5 grams (excluding packing material weight) shall be acceptable. The individual standing pouches shall be packed in a suitable secondary packaging such as corrugated cartons. The materials for Primary and Secondary packing shall be supplied by the contractor. Artwork to be printed on the pouch and cartons will be provided by KCMMF.

### 3.7 Delivery:

The Contractor shall supply the intended quantity at Central Products Dairy, Alappuzha, Kerala within 15 days of receipt of indent/ Purchase Order. However, the indents for the month of August and September will be placed in advance to make it convenient to arrange larger quantity of raw materials required for meeting the demands during "Onam" and "Vishu" festival seasons in Kerala. The indent will be forwarded from Central Products Dairy, Alappuzha. Our average monthly requirements and the Onam, Vishu festival seasons requirements are as follows.

### 3.8 Payment Terms:

GST invoices shall be raised and shall be submitted to Manager, Central Products Dairy, KCMMF Limited, Punnappra P.O., Alappuzha, Kerala - 688004 in the below mentioned address along with the consignment. Payment will be released within 10 days through online payment from the date of receipt of products in good condition as per the quality standards described.

### 3.9 Product Specifications:

The ingredients used for the preparation of 100 kg of Ready to Drink Palada with Extended Shelf life should be in the below said proportion.

### 3.10 Shelf Life:

The Product shall have a shelf life of minimum **12 months** from the date of manufacture and it should be supplied to our Dairy within a period of 20 days after production.

### 3.11 Product Consistency:

- Ada has to be uniformly cooked through high heat treatment process and it shall not affect the texture of the product.
- Natural colour of 'Palada' has to be retained after the sterilization process.
- Ada shall not get settled at the bottom portion of Pouch during storage; which means Ada should be in floating stage.

### 3.12 Recipe Change:

Normally no modifications in the recipe will be allowed. However, Party can make changes in the given recipe, if required for conforming to the quality standards stipulated by Food Safety and Standards Act. But, such changes shall be made only after obtaining written consent from our side.

### **3.13 Quality standards:**

The physical, chemical and bacteriological quality of "Ready to Drink Palada" with extended shelf life and its price shall be the essence of this contract. Party shall manufacture the product as per the quality standards and recipe described in the Item Specifications. A sample of product manufactured as per the suggested recipe shall be supplied to Alappuzha Dairy for approval before the commencement of regular supply. Party shall maintain the same quality as per this approved sample. Party shall ensure that "Ready to Drink Palada" in 400 g pouches supplied to the Central Products Dairy, confirm to the standards specified in the Food Safety and Standards Act (herein after referred to as FSSAI). If any Quality /quantity variations are reported by consumers or detected by Food Safety Officers, or any other law enforcing officers of the Government at any stage, Party will be solely responsible for the defect and offence. For the purpose of legal issues related to the quality of Ready to Drink Palada, KCMMF Limited will be a marketing agency and all legal liabilities related to the quality/quantity of the product shall vest with the Party. Party shall also compensate the losses in this regard occurring to KCMMF and its distributors and consumers.

### **3.14 Damage replacement:**

Additional packets @1% of the off take, towards provision for damage replacement and another one piece as representative sample shall be supplied free of cost along with each consignment.

### **3.15 Rejection Clause:**

The Quality Control Department of MILMA Central Products Dairy, Punnappra P.O., Alappuzha, Kerala will draw a random sample from each consignment of the Product supplied and verify whether the Product and packing materials conform to the legal specifications and the specifications mentioned in the Item Specification. If the quality of the product, its packing etc. does not conform to specifications or found defective otherwise, we reserve the right to reject the consignment summarily. Supplies not made as per delivery schedule are also likely to be rejected. In case of rejection of the product, we will not be responsible for payment of any damage to the Party.

### **3.16 Visit at supplier premises:**

Before finalization of the Bid and after executing agreement, contractor shall allow dairy officials to check & verify manufacturing facilities and processing methods at your premises without any hindrance and hesitation.

- 3.17** Item shall be delivered as requested and as per the requirement of the Central Products Dairy, KCMMF Limited Punnappa P.O., Alappuzha, Kerala.
- 3.18** No interruption in supply shall be allowed. The contractor shall ensure the supply of the required quantity without any delay. In case, the loss due to the delay in supply of material or due to the alternate arrangement made by the Alappuzha Dairy for supply of material shall be recovered from the contractor.
- 3.19** The rate shall be quoted for 1 no. of 400 grams "Ready to Drink Palada" with extended shelf life pouch to be supplied to MILMA Central Products Dairy, Punnappa P.O., Alappuzha, Kerala - 688004 which is inclusive of cost of all raw materials, processing cost, packing cost including consumables, loading cum unloading charges, transportation charges and miscellaneous charges if any up to Central Products Dairy, KCMMF Ltd, Punnappa P.O., Alappuzha, Kerala and the rate shall be exclusive of GST.
- 3.20** We will provide Double toned milk in packed conduction to the manufacturer/supplier at the rate of Rs.52/- per litre 'FOR' Manufacturer premises. The final rate will vary by 45 paise per 400 gm of Palada packet for every one rupee increase or decrease in per litre supply price of Double toned Milk.

#### **4. OTHER TERMS & CONDITIONS**

- 4.1** The damages that are caused by the supplier due to his negligence while loading and stacking and on transit will have to be compensated by the supply contractor.
- 4.2** In case of negligence or misconduct of supplier or his Staffs or due to the problems in operation of his transportation vehicle any loss/damage occurred to the assets (fixed or movable) of the Dairy will be recovered from supplier's eligible bills/Security deposit.
- 4.3** Payment will be made as per the actual quantity supplied within maximum 15 days from the date of receipt of invoice through bank payment.
- 4.4** The successful bidder shall remit a security deposit amount of Rs.50,000/- (Rupees Fifty Thousand Only) to Central Products Dairy, KCMMF Limited, Punnappa P.O., Alappuzha, Kerala - 688004 within fifteen days after finalizing the supply contract. No Interest will be paid for security deposit. The security deposit will be refunded only at the end of the successful completion of the contract period. The

security deposit will be forfeited in favour of KCMMF Ltd, Central Products Dairy, Punnappra P.O., Alappuzha, Kerala - 688004 in case of any violation of the terms and conditions or abandoning of the contract by the contractor without due notice.

- 4.5** The successful bidder shall execute an agreement with the undersigned in a non-judicial stamp paper worth Rs.200/- (Rupees Two hundred only) incorporating all the terms and conditions of the contract for the satisfactory fulfillment of the contract.
- 4.6** The communication to the bidder shall be channeled only through email and hence the bidders are advised to check their email regularly to get latest informations. Scanned copy of the work order will be sent to the email id of the successful bidder once the administrative formalities are completed. Therefore, regular monitoring of email by the bidder is necessary.
- 4.7** An agreement shall have to be executed between the service provider and Managing Director, KCMMF Limited for the satisfactory accomplishment of the contract.
