Terms and conditions

1. All the works shall be carried out as per the directions of our plant Engineer.
2. The materials supplied for works shall be of approved make and shall be inspected & approved by our Engineers before acceptance
3. You shall arrange for all compliance to the ESI rules in force and submit the ESI details of the workers before the commencement of the works as per the Work Order. If the Contractor is not registered for ESI, he shall submit the details of the workers, like Aadhar card and Bank pass book to register with ESI from the HR Department of CPD, Punnapra, before the commencement of the works as per the Work Order. If contractor is having ESI registration or registered from CPD, Punnapra, deduction as per the ESI regulation & norms will be made from the invoice amount after the works.

4. No one shall be deployed for the works without a valid ESI registration. Milma Central Products Dairy will not be responsible for any accident/mishaps, etc. during execution of work.
 5. You shall provide all the tools & tackles, labour etc for the works.
 6. The amount quoted must be inclusive of all.
 7. All the safety measures to the men and material are in your scope and must ensure that all the safety measures had taken prior to the job.
 8. The payment will be made only for the actual measurement/quantity executed and nothing will be paid extra on this account.
 9. All materials/debris/tools/equipments, etc, shall be completely removed from the site as per the instruction of our Maintenance Engineer.
 10. All the work should be completed in all respects within four weeks from the date of receipt of work order. Any demurrage/detention/penalty charges incurred due to the delay in the completion of the work shall be charged on percentage basis to the Contractor's account.
 11. The works if found inferior in quality/ workmanship on completion shall be redone at contractor's risk and cost.
 12. All materials/debris/tools/equipments, etc, shall be completely removed from the site as per the instruction of our Maintenance Engineer.
 13. **Payment terms:** 95% payment will be released after the successful completion of the works and submission of original invoice and the remaining 5% will be released only after the guarantee period of one year.
- 14. Preferably sealed quotations shall reach our office on or before 2.00 P.M on 05.09.2024 and will be opened at 2.30 P.M on the same day.**
