- The entire work must be completed in 15 days from the work order acceptance from you.
- The work should be carried out in consultation with manager, CPD, Punnapra or the authorized representative of Manager, Punnapra and should be strictly as per the specification and direction as per the directions.
- The materials supplied for works shall be of approved make and shall be inspected & approved by our Engineers before acceptance.
- The CPD, Punnapra or its representatives shall have all the rights to inspect and or test the materials supplied by you to confirm their conformity of the entire work.
- 5. You shall arrange for all compliance to the ESI rules in force and submit the ESI details of the workers before the commencement of the works as per the Work Order. If the Contractor is not registered for ESI, he shall submit the details of the workers, like Aadhar card and Bank pass book to register with ESI from the HR Department of CPD, Punnapra, before the commencement of the works as per the Work Order. If contractor is having ESI registration or registered from CPD, works as per the Work Order. If contractor is having ESI registration or registered from the invoice amount after Punnapra, deduction as per the ESI regulation & norms will be made from the invoice amount after the works.
- 6. No one shall be deployed for the works without a valid ESI registration. Milma Central Products Dairy will not be responsible for any accident/mishaps, etc. during execution of work.
- 7. You shall provide all the tools & tackles, labor etc for entire the works.
- 8. The contractor is required under the contract to deliver the goods for destination and shall arrange and paid by the contractor.
- All the safety measures to the men and material are in your scope and must ensure that all the safety measures had taken prior to the job.
- 10. The quantity mentioned is tentative and may vary +/- either side. The payment will be made only for the actual quantity executed/site measurement but not exceeds than the total contract value.
- 11. All the work should be completed in all respects within 15 days from the date of receipt of work order. Any demurrage/detention/penalty charges incurred due to the delay in the completion of the work shall be charged on percentage basis to the Contractor's account.
- 12. The entire work should be guaranteed for one year. If any work found inferior in quality/ workmanship on completion shall be redone at contractor's risk and cost.
- 13. All materials/debris/tools/equipments, etc, shall be completely removed from the site as per the instruction of our Maintenance Engineer.
- 14. **Payment terms**: 95% payment will be released after the successful completion of the works and submission of original invoices. Balance 5% will be released only after the guarantee period of one year
- 15. Preferably sealed quotations shall reach our office on or before 2.00 P.M on 05.09.2024 and will be opened at 3.00 P.M on the same day.
