Terms and Conditions.

1. Bidders are requested to submit their bid for DORB preferably from the states like **Uttar Pradesh/Madhya Pradesh/Jharkhand/West Bengal**. Preference will be given for attractive quotes received for material from UP and then only the option of probing material from other states mentioned above will be considered. However, the Bidders shall go for bids for item from the states like Chhattisgarh / Madhya Pradesh/ /Jharkhand/West Bengal also, once the material availability from the state of UP cannot be arranged, by all means. The finalisation of the bid will be based on the source of material, its quality factors and delivery schedule.
2. In the case of Bids submitted by Traders (those who are not Manufactures/Solvent Extraction plants), their offers may be considered subjected to the condition that order against such bid shall be placed in favour of the Solvent extraction plant from where the material will be despatched. Such Bidders must confirm the address and other details of the Solvent extraction plant while submitting the offer.
3. The Bidders shall provide the details on Source of supply and other relevant details .
4. Rebate if any, will be calculated on per point/fractional basis.
5. Item offered must have quality parameters specified above.
6. Aflatoxin B1 content shall not exceed 20 ppb. In the event that the supplied material is found to contain Aflatoxin B1 above 20 ppb upon testing, the purchaser reserves the right to apply a suitable rebate.
7. The price quoted should be **per MT rate FOR Chalakudy Railway Good Shed for taking the material to Cattle Feed Plant, Pattanakkad/Malampuzha.**
8. The order arising out of this enquiry shall be governed by the laws of Indian Unions and the courts in Trivandrum shall have the jurisdiction.
9. **KCMMF reserves** the right to accept or reject any bid or a part of the bid or to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Buyer's action.
10. If the bidder gives wrong information in his tender **KCMMF** reserves the right to reject such tender at any stage or to cancel the contract.
11. 75% payment will be given within 20 days of the receipt of the material and balance amount will be given within 40 days along with analysis report and statement of accounts.

12. The samples taken during the unloading of the Rake, will be simultaneously tested in Cattle Feed Plant Malampuzha and Cattle Feed Plant Pattanakkad. This is to ensure exact analysis report.
13. **The material shall be supplied in new HDPE/PP bag with machine stitching and the weight of the material in each bag shall be in the range of 45 kg to 54 kg. This has to be strictly ensured as there were cases of interruption earlier in unloading of lighter/heavier bags received by wagon, exceeding the above range specified. 200 gm will be deducted as bag weight against each bag delivered.**
