Price Bid shall only be submitted through **online**. Details regarding remittance of Bid Submission Fee and Bid Security, Bid preparation and submission are mentioned in the bid document.

The bids shall be opened online on 22.12.2022, 15.00 hrs at the office of the Deputy Engineer, KCMMF, Milma Bhavan, Pattom P.O, Thiruvananthapuram-4 in the presence of the Bidders/the authorized representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday, or on a non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.
