The bidding shall be subjected and binding to the following terms and conditions

I. General Terms & Conditions:

- 1. PRICE BASIS:** All prices must be quoted as for site basis, including all taxes and duties, freight, packing, forwarding transit risk, loading, etc. This must includes all service charges like pre- check up, Cleaning & servicing the equipment and stamping of weighing machines through legal Metrology.
- 2. PRICE VALIDITY:** The competitive price offered shall remain valid for 3 Months for acceptance from the date of your offer. Any deviation in your price validity period shall be clearly mentioned in your quotation itself.
- 4. PAYMENT MODE:** 100% payment will be released only after satisfactory execution and completion of the job and submission of invoice in duplicate along with certificate within the stipulated time period. Advance payment will not be entertained.

II. Specific Terms & Conditions:

1. **Essential Documents:** The bidder shall furnish the following details/documents (as copy) for becoming eligible to technically qualify in the bid
 - a. Name of the Bidder / Enterprise entitled to supply
 - b. Company Registration Certificate
 - c. Address proof of the Enterprise
 - d. Valid ID proof of the Bidder (such as Adhar)
 - e. PAN copy
 - f. GST registration certificate copy (if registered)
2. **The total amount to be quoted in the quotation is the total amount for the arrangement of stamping work to be completed in D quarter of 2025.**
3. Any deviations in the price quote, validity period, payment mode from as stipulated above shall be clearly specified.
4. **Rates shall be quoted only in Indian Rupees for the stamping work.** The rates shall remain firm for the entire duration of the contract. Price quotations containing dynamic pricing or any conditional clauses will be summarily rejected. The stamping process shall be carried out in the D quarter of 2025 as specified in the Annexure, and the work shall be planned to ensure that the certificates are obtained on or before the end of 2025 December 31st.
5. Spare parts if any replaced at the time of service/stamping will be paid extra. Same shall be informed prior to the replacement for the management approval.
6. **Right of Acceptance:** The undersigned reserves the right to accept the offer either in full or in part, or to reject it entirely, without assigning any reason.
7. **Bid Opening:** Only sealed quotations received by postal are valid and considered for evaluation. Open quotations submitted in hand or sent by email will be treated non-responsive and will be totally rejected. Hence the bidders are requested to send their valuable sealed quotations by postal well in advance before the date of opening. Sealed quotations shall reach our office on or before 3:00 PM of **10.12.2025** and the received quotations will be opened on the same day at 3.30 PM in the presence of bidders if any available. Quotations received after 3:00 PM will be rejected.
8. **Bidder Confirmation:** Technically qualified bids will only be considered for financial evaluation. Price bids will be assessed in accordance with the Least Cost Based Selection System. All the bids will be evaluated on the basis of the eligibility criteria through verification of all the essential documents submitted along with the terms & conditions complied by bidder. Though the L1 bidder will be the preferred bidder, simply quoting of lowest rate does not confer any right for selection of the bidder at the rate quoted. KCMMF reserves the right to confirm and finalize the bidder. Quoting of same rates

(L1 only) by more than one bidder could be construed as an exceptional circumstance. In such cases, all the bidders who have quoted the same lowest rates shall be called for and one more chance will be given for on spot quoting if bidders are present or negotiated quote may be collected via mail with a closing time for rate finalization. If the negotiated quotes are still the same, KCMMF reserves the right to award the purchase order to that party at its discretion subject to the reputation/performance of the party based on their business volume, prompt service, customer satisfaction etc. or to cancel the tender for proceeding with re-tender.

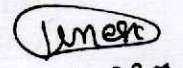
