### **QUOTATION NOTICE**

**Sub: Inviting sealed competitive price quotations for the supply of Boiler Chemicals for one year at Cattle Feed Plant, Malampuzha**

**Kerala Co-Operative Milk Marketing Federation Limited (MILMA), Cattle Feed Plant, Malampuzha, Palakkad - 678651** invites your sealed competitive price quotations **for the supply of Boiler Chemicals for one year** within a shortest delivery period as per the technical specification and schedule of quantities mentioned in **Annexure** enclosed herewith. The bidding shall be subjected and binding to the following terms and conditions

#### **I. General Terms & Conditions:**

**1. PRICE BASIS:** All prices must be quoted as FOR site basis, including all Taxes cum duties and freight, packing, forwarding, transit risk insurance, loading, miscellaneous incidental charges etc. for the safe delivery of the items at our end. Nothing extra will be paid on this account for any reason. Special discount offered if any shall be mentioned separately.

**2. PRICE VALIDITY:** The competitive price offered shall remain valid for 3 Months for acceptance from the date of your offer. Any deviation in your price validity period shall be clearly mentioned in your quotation itself. Same rate shall be applicable till the end of one year from the date of first supply-no fluctuation during this period is acceptable in any case.

**3. PAYMENT MODE:** 100% payment will be released against invoice within 30 Days of delivery for each lot supply or bulk supply as applicable. Advance payment will not be entertained.

**4. DELIVERY:** The items shall be supplied within 30 days from the date of receipt of the confirmed purchase order at the following address: **Kerala Co-Operative Milk Marketing**

However, early delivery will be appreciated. In case the supplier fails to deliver the items within the stipulated period, the Federation reserves the right to terminate the order without assigning any reason.

**5. LIQUIDATED DAMAGES**

**CLAUSE:**

In case the supply of ordered items is not completed within the stipulated delivery period, liquidated damages @1% of total purchase value per week will be charged for the items so delayed subject to a maximum of 5% of the total value.

**II. Specific Terms & Conditions:**

1. **Essential Documents:** The bidder shall furnish the following details/documents (as copy) for becoming eligible to technically qualify in the bid
  - a. Name of the Bidder / Enterprise entitled to supply
  - b. Company Registration certificate
  - c. Address proof of the Enterprise
  - d. Valid ID proof of the Bidder (such as Adhar)
  - e. PAN copy
  - f. GST registration certificate copy (if registered)
2. Any deviations in the specifications of the items quoted shall be clearly specified.
3. The supplied chemicals shall be suitable for maintaining: Boiler feed water hardness below permissible limits, Prevention of scale formation inside boiler tubes, Blowdown water pH within operating range as required by plant operation, prevention of corrosion & rust etc.
4. Each batch supplied shall be accompanied by: A)Manufacturer Test Certificate, B) Material Safety Data Sheet (MSDS), C) Batch No., Manufacturing Date and Expiry Date details
5. Chemicals shall be supplied in **sealed, leak-proof HDPE cans/drums** with proper labeling indicating product name, batch number, safety instructions and handling precautions.
6. Chemicals supplied shall have minimum 12 months usable shelf life from date of supply.
7. Any deviations in the price quote, validity period, payment mode from as stipulated above shall be clearly specified.
8. Rates shall be quoted only in Indian Rupees. Rates shall be fixed during the entire validity period and Price quotations with dynamic pricing and including any other conditional clauses will be summarily rejected.
9. **Right of Acceptance:** The undersigned reserves the right to accept the offer either in full or in part, or to reject it entirely, without assigning any reason.
10. When quoting the price for each item, it is mandatory to add the item code of the respective item.

**11. Bid Opening:** Only sealed quotations received by postal are valid and considered for evaluation. Open quotations submitted in hand or sent by email will be treated non-responsive and will be totally rejected. Hence the bidders are requested to send their valuable sealed quotations by postal well in advance before the date of opening. Sealed quotations shall reach our office on or before 3:00 PM of **20.02.2026** and the received quotations will be opened on the same day at 3.30 PM in the presence of bidders if any available. Quotations received after 3:00 PM will be rejected.

**12. Bidder Confirmation:** Technically qualified bids will only be considered for financial evaluation. Price bids will be assessed in accordance with the Least Cost Based Selection System. All the bids will be evaluated on the basis of the eligibility criteria through verification of all the essential documents submitted along with the terms & conditions complied by bidder. Though the L1 bidder will be the preferred bidder, simply quoting of lowest rate does not confer any right for selection of the bidder at the rate quoted. KCMMF reserves the right to confirm and finalize the bidder. Quoting of same rates (L1 only) by more than one bidder could be construed as an exceptional circumstance. In such cases, all the bidders who have quoted the same lowest rates shall be called for and one more chance will be given for on spot quoting if bidders are present or negotiated quote may be collected via mail with a closing time for rate finalization. If the negotiated quotes are still the same, KCMMF reserves the right to award the purchase order to that party at its discretion subject to the reputation/performance of the party based on their business volume, providing extended guarantee period, prompt service, customer satisfaction etc. or to cancel the tender for proceeding with re-tender.



### Technical Requirements & Specification

**Boiler specification:** Fire tube boilers of 91 square meters rating with maximum continuous evaporation capacity of 2000 kg/hr

- Maximum pressure: 10.54 kg/cm<sup>2</sup>
- Water capacity : Approx. 12000 Litres / day max.
- Total number of boilers : 2 nos (alternatively used)

**Scope of chemicals supply:** Annual supply of liquid /powder treatment chemicals for the above boilers:

- **Anti-Corrosion agent:** Ability to reduce dissolved oxygen, Maintain condensate pH within the limit, prevent corrosion & rust, Must be compatible with other boiler water treatment chemicals softeners, phosphates etc and Must remain effective under high temperature and high-pressure operating conditions
- **Anti-scalant:** Multifunctional liquid boiler water treatment chemical, often combining scale inhibitors, sludge conditioners, and corrosion inhibitors, ability to prevent scale (calcium, magnesium, silica) and inhibit corrosion, Prevents hard scale (carbonate/sulphate/silica) and controls iron deposits
- **PH Booster:** alkaline treatment chemical used to raise the pH of feed water and boiler water to prevent corrosion and scale formation. Must be compatible with other standard water treatment chemicals, Should be non-toxic and non-corrosive to handlers when used at recommended dosages

The above chemicals shall be able to maintain the high purity and quality of steam generation.

**Grade Standard:** Technical Grade suitable for industrial boiler systems.

**Compatibility:** Must be compatible with existing water pre-treatment. Vendor may visit the factory for details if required.

**Service & Support:**

- Vendor to provide onsite visits on every month to test water quality and optimize dosage upto the completion of the purchased chemicals.
- Testing kits: Provision of necessary testing reagents for, at least, alkalinity, sulfite/oxygen scavenger, chloride, and pH.
- Material Safety Data Sheets (MSDS): Required for all chemicals
- Vendor to provide certificates of analysis (COA) for each batch.
