## NOTICE INVITING SEALED QUOTATIONS

**Sealed competitive quotations** are invited from experienced transport contractors/logistics providers for the transportation of **Agglomerated Skimmed Milk Powder (SMP)** from Indapur (Maharashtra) to Central Products Dairy, Alappuzha (Kerala).

### I. SCOPE OF WORK

## II. VEHICLE SPECIFICATIONS (COMPLIANCE REQUIRED)

Bidders must note that **Refrigerated or Container trucks are NOT required** .

- **Vehicle Type:** Standard **Open Trucks/Lorries**.

*2 Vehicles of 25 MT capacity each (Multi-axle Taurus/12-wheeler preferred).*

- **Protection:** Must be covered with **high-quality, leak-proof Tarpaulin** sheets to prevent moisture ingress.
- **Hygiene:** Floor must be clean, dry, odorless, and free from protruding nails/sharp edges to prevent bag damage.

*Prohibited:* Vehicles previously used for fish, fertilizer, chemicals, or hazardous waste.

- **Tracking:** Driver must possess an active mobile phone (GPS preferred).

## III. TERMS AND CONDITIONS

- **Rate:**
  - The rate shall be quoted per **Metric Tonne (MT)** .
  - **Inclusions:** Vehicle hire, fuel, driver bata, toll charges, interstate permits, Loading charges at Pickup Point, and **Attimari (handling) charges at Destination**.
  - **Exclusions:** Unloading charges at Central Products Dairy, Alappuzha (Borne by Central Products Dairy, Alappuzha).
  - **GST:** Rate must be **exclusive of GST**. GST will be paid by Central Products Dairy, Alappuzha on RCM basis.
- **Payment:** Payment will be released within **20 days** of submission of original bills, acknowledged LR, and Weighbridge slip.
- **Transit Time:** Maximum **4 Days** from the time of lifting. A penalty of Rs. 1,000/- per day will be levied for unjustified delays.
- **Route:** The preferred route is Indapur → Solapur → Vijayapura → Bengaluru → Salem → Coimbatore → Alappuzha. **However, the transporter is free to choose any suitable route** provided the material reaches the destination safely within the stipulated transit time.
- **Statutory Compliance & Quality Assurance:**
  - **FSSAI & Motor Vehicles Act:** It is preferred that the transporter holds a valid FSSAI license for food transportation and complies with all Motor Vehicles Act regulations.
  - **Pre-Loading Inspection:** It is preferred that the vehicle undergoes inspection prior to loading. If the vehicle is found unhygienic (wet floor, off-odors, oil leaks), the transporter may be requested to arrange a replacement.
  - **Cargo Safety & Insurance:**
    - **Transit Insurance:** Transit Insurance for the cargo will be arranged and borne by Central Products Dairy, Alappuzha.
    - **Transporter Liability:** Notwithstanding the insurance policy, the transporter remains fully liable for any damage, theft, pilferage, or loss of stock due to negligence, accidents, or exposure to rain/moisture during transit. In case of wet damage due to poor tarpaulin coverage, the full cost of the damaged stock will be recovered from the transporter.
- **Delivery & Logistics:**

- **Pre-Dispatch Communication:** The transporter must establish proper formal communication with both the Unit Head/Manager at Central Products Dairy, Alappuzha and the authorized contact person at the Source Dairy (M/s. Nature Delight Multi State Cooperative Dairy, Indapur) to coordinate the lifting schedule, vehicle placement, and documentation formalities.
- **Termination & Consequences of Default:**
  - Central Products Dairy, Alappuzha reserves the right to terminate the contract immediately if the transporter fails to place the vehicle within 24 hours of the confirmed lifting date.
  - In the event of default or failure to execute the work after acceptance, the transporter may be **debarred/blacklisted** from participating in future tenders of Central Products Dairy, Alappuzha.
- **Indemnity:** The bidder shall fully indemnify and hold harmless Central Products Dairy, Alappuzha against all actions, suits, claims, and demands arising from any accident, injury to crew/third parties, or violation of traffic laws during the execution of the contract.
- **Force Majeure:** Failure or delay in operation due to events beyond reasonable control (Floods, Strikes, Acts of God) shall be considered if notified within 24 hours with documentary evidence. Parties will mutually agree on timelines in such events.
- **Dispute Resolution:** Any disputes arising from this contract/work order shall be subject to the exclusive jurisdiction of the Courts in Alappuzha, Kerala.
- **Validity:** The quoted rate shall be valid for this specific consignment only.
