95 % payment will be released within ten days on satisfactory completion of entire supply and installation, balance 5 % will release after guarantee period.

6. Submission of Quotations and Opening

The offer shall be submitted in original in a sealed cover Quotation No. No.187/PC:HOB:CCTV:GEN/2021 dtd. 03.01.2022.

The offers should reach this office on or before 14.30 hrs. on 12.01.2022 and will be opened at 15.30 hrs. on the same day in the presence of interested quotationers or their authorized representatives.

7. General

- i. All effective equipment supplied for the installation of the surveillance system should be inspected by the concerned officials before installation.
- ii. Guarantee period and make of the equipment's shall mentioned in the tender document each and every equipment separately.
- iii. The system must have the privilege of retaining the footage captured by the camera for at least a month.
- iv. Surveillance system installed at the head office should have the facility to monitor the camera footage recorded from all our units .
- v. All possible damages that may occur during the warranty period shall be borne by the Contractor at his own risk and shall be replaced with free of cost.
- vi. The manufacturer's name of each device and the warranty of the device must be accurately recorded in the tender.

- vii. The UPS power can be used to provide the required power to the Surveillance system, and the required wiring should be done by the contractor.
- viii. It is the responsibility of the contractor to set up and operate the system.
- ix. The existing device should have the facility to install six more cameras in the future.
- x. No telegraphic/email/telephonic tender will be considered.
