The scope of work involves supply and media change service of water filter, activated carbon, softener resin for water treatment plant. This work also includes softener valve inspection for any faulty function and supply of 40 NB softener valve if necessary.

Bill shall be prepaid in duplicate in the name of Manager, Cattle feed plant, Pattanakkad and shall be submitted to the Assistant Manager/Production engineer for necessary certification and recommendation for payment.

Payment shall be released against submission of original invoices for the entire works completed. While settling the bills, applicable statutory deductions will be made.

SUBMISSION OF QUOTATIONS AND OPENING:

Sealed quotations must be submitted super scribing Quotaion for **CFPT/PE/555/2025-26 Water treatment plant Media change.**

The offer should be submit to this office on or before 04.02.2026 (3pm) and opening will be on the same day 3.30pm. .

GENERAL CONDITIONS

1. An **EMD of Rs.3000/-** has to paid in advance through **NEFT/RTGS/cash in favour of Manager, Cattle Feed Plant, Pattanakkad.**
2. Interested contractors are requested to visit the site during working days from **10AM to 4PM** on all working days before posting the quotation.
3. The materials shall be inspected by our engineers before acceptance. The materials shall be mentioned in your offer approval item.
4. All materials/debris/tools/equipments etc. shall be completely removed from site before taking over.

5. Specifications shall be as per that mentioned in the schedule of quantities. In case of doubt, our Engineer shall be contacted before taking up the particular work.
6. Payment shall be effected only for those quantities actually executed subjected to a maximum of quoted value.
7. Each item of work shall be approved prior to commencement of the next work.
8. Water and power required for the work alone will be provided at free of cost. The contractor shall bring the materials and Workers required for the jobs. The contractor shall examine the prevailing local rates for unskilled labourers before quoting for the work.
9. The contractor shall arrange for all compliance to the ESI/PF rules in force. Cattle Feed Plant shall not be liable for any benefits/compensation to the workers engaged by the contractor, in the event of accidents/mishaps etc. during execution of work. The contractor shall provide suitable safety measures to Workers.
10. The contractor or his workmen shall not interfere in any activity of the Plant and/or cause any damages to buildings/property. The entry of all such labourers will be on the basis of gate pass, which will have to be arranged by the Contractor prior to starting the work. In the event of any damage to Cattle Feed Plant's property, the contractor alone shall be liable.
11. Income tax, Sales Tax on works contract, ESI/TDS and other applicable statutory deductions shall be affected while settling bills.
12. Work found inferior in quality/workmanship on completion shall be redone at contractor's risk and cost. An undertaking in this regard must be submitted along with bill.
13. The contractor shall provide all the material required for the works.
14. The contractor shall supply tools and tackles required for the works.
15. The entire works shall be completed within 15 days from the date receipt of the order.
16. All the works shall be carried out as per the directions of our plant engineer.
17. The contractor shall guarantee to rectify any defect noticed in works due to bad workmanship within one year from the date of completion of the work.
