

- 1. The rate quoted should be inclusive of material cost (the conveyor chain and sprocket will be supplied by), labour charges, GST, P&F, freight charges, loading charges, etc. The unloading charges at our site will be paid by us.
- 2. Interested parties can visit our dairy in between 10.00 AM to 4.00 PM on working days for verifies the works.
- 3. All the works shall be carried out as per the directions of our Plant Engineer.
- 4. The tray conveyor repair works shall be arranged in a mutually agreed date without interruption of our pouch filling section. The erection should be carry out at night shifts between 8.00 PM to 5.00 AM for un interruption of our pouch filling section.
- 5. The materials shall be approved make and should be inspected & approved by our Engineers before acceptance.
- 6. The quantities indicated in the schedule are only tentative and may vary to the +/side. However, payment will be made for the actual quantities executed at site on unit
  rate basis.
- 7. You shall arrange for all compliance to the ESI/PF rules in force. Milma Central Products Dairy shall not be liable for any benefits/mishaps, etc. during execution of work. The contractor shall provide suitable safety measures of workers.
- 8. Work found inferior in quality/ workmanship on completion shall be redone at contractor's risk and cost.
- All the work should be completed in all respects within 15 days from the date of receipt of work order.
- 10. An Earnest Money Deposit (EMD) of Rs. 4500/- shall be remitted either by cash/ NEFT (State Bank Of India, Account Number 67192090757, Punnapra, Alappuzha-4, IFSC Code SBIN0070215) in favour of Manager, Central Products Dairy, Alappuzha. The details shall be enclosed along with the offer. The amount shall be returned only after finalization of the tender.
- 11. The sealed quotations shall reach our office on or before 2.00PM on 23.07.2022 and will be opened at 03.00 P.M on the same day.
- 12. <u>Payment</u>: 95% payment will be released after completion of the works and balance 5% will be release against a bank guarantee for the same amount from a nationalized bank/scheduled/new generation bank. If not will be release only after the guarantee period of 12 months.
