Sub: construction of a partitioning room in FPG for storage of Milmamin packets and Ksheeravardhini buckets

Sealed quotations are invited from reputed and experienced contractors for the construction of a partitioning room using Galvanized Iron (GI) mesh at the FPG section of KCMME Cattle Feed Plant, Malampuzha, Palakkad, for the safe and secure storage of Milmamin packets and Ksheeravardhini buckets.

Scope of Work

Construction of a GI mesh-partitioned storage room (Length 33 feet, width 12 feet and Height 10 feet) at the right-end corner of the FPG section, including the supply and installation (All works including fabrication, labour, etc) of the following structural and supporting materials:

GENERAL TERMS & CONDITIONS

1. Applicable statutory deductions such as GST, Income Tax, EPF, ESI, and Work Contract Tax will be effected during bill settlement. Contractors must remit statutory contributions and submit remittance proofs (Challans) to avoid deductions.
2. All essential materials/tools & tackles must be brought to the site in advance and listed for verification.
3. Materials will be accepted only after inspection and approval by Plant Engineers.
4. Each stage of work must be approved by the Engineer before proceeding to the next.
5. The contractor is responsible for ESI/PF compliance and worker safety. Any accident or mishap will be solely the contractor's responsibility.
6. Contractor's workers will require gate passes, and should not interfere with plant operations or cause damage to property.
7. Day-to-day operations of the plant must not be disrupted by the construction work.
8. Any work of poor quality must be redone at the contractor's cost.

SPECIFIC TERMS & CONDITIONS

1. The contractor shall supply all materials, tools, and tackles for the execution of the work.

2. Prices must be quoted on an "FOR site" basis, inclusive of labour, taxes, duties, packing, freight, loading/unloading, and all incidentals.
3. The quotation shall be valid for 1 month from the date of submission.
4. The entire work must be completed within 15 days from the receipt of the work order.
5. Work must be executed as per the instructions and supervision of the Plant Engineer.
6. Any defects due to bad workmanship must be rectified free of cost during the guarantee period of 1 year.
7. All safety equipment and work permits must be arranged by the contractor prior to the commencement of work.
8. Payment Terms:
 - o 90% payment will be released upon satisfactory completion of work.
 - o 10% will be released after the guarantee period of 1 year.
 - o Our Bankers: SBI Palakkad / Canara Bank Malampuzha.
9. Penalty Clause: A penalty of 1% of the total quoted value per day will be levied for delay beyond the stipulated 15 days, up to a maximum of 10%.
