#### Terms & Conditions:

- 1. PRICE BASIS: All prices must be quoted as FOR site basis, including all taxes and duties, freight, packing, forwarding transit risk, loading, etc. for the safe delivery of the items and nothing extra will be paid on this account.
- 2. VALIDITY: The offer should be valid for 3 MONTHS for acceptance from the date of your offer.
- 3. GUARANTEE: The items supplied to be guaranteed for performance and quality for minimum one year. If any item found damaged, bad quality etc. to be replaced free of cost during the guarantee period.
- 4. PAYMENT: 100% payment will be released on satisfactory receipt of items at our site.
- 5. LIQUIDATED DAMAGES CLAUSE: In the case of supply is not completed within the stipulated period, liquidated damages @1% per week will be charged for the items so delayed subject for a maximum of 10% of the total value.
- 6. The Bidder shall be capable of supplying stitching thread in a single delivery (quantity mentioned in the notice) or for a period of one year with at least 170 cones (as per specification mentioned) per month in stipulated time period.
- 7. Scope of the Supply Contract: The scope of the contract includes the regular supply of approximately 1700 nos of stitching thread cones as per the specifications (Stitching Thread, 4/10 Poly Cotton, 4000 meters, 1kg cone) to KCMMF Limited, Cattle Feed Plant, Malampuzha, Palakkad, as a bulk quantity or within a period of one year based on the purchase order requirement such that the items shall be delivered within agreed schedule from the PO date.
- 8. Supply Contract Terms and Conditions:
- A)The contract period shall be for one year from the date of the purchase order.
- B) The Manager reserves the right to extend the supply contract for further periods as required upon mutual agreement.
- C) The supplier shall ensure timely delivery of the stitching thread as per the agreed schedule.
- D) The stitching thread supplied shall be guaranteed for performance and quality for one year. Any defective or damaged items shall be replaced free of cost.
- 9. Schedule of Supply Quantities and rates:
- A) The rate shall be quoted for a Single Stitching Thread cone which is to be complied as

per the specifications. The quoted rate shall be inclusive of cost of materials, all applicable taxes/duties and all your incidental charges (viz. Manpower cost for loading, unloading, transportation, weighing, counting, bundling charges, GST etc.) and all other charges applicable if any for reaching our office and nothing extra will be paid apart from the quoted rate on any account.

B) Rate quoted per stitching thread cone should be quoted both in figures as well and in words. In case of discrepancy in the rate quoted in figures and in words, the amount quoted in

words shall be taken as final and binding on the party.

C) Quantity indicated in the notice are only tentative and may vary to the +/- side. However, payment will be made for the actual quantity supplied at site as per the directions of Production Head on unit rate basis. No extra claim shall be entertained on this account.

D) The rate quoted per Stitching thread cone should remain firm for the entire duration of

contract and nothing extra will be paid on any account.

E) The supply shall be made in regular intervals as requested by the plant, ensuring that there are no interruptions in the stitching operations.

10. Stitching thread supplied are supposed to be rejected due to below mentioned reasons shall be replaced free of cost.

(A) Any physical damages in thread

(B) Weight difference from the notice specification.

(C) Variation in total length of thread

(D) Material mismatch from the notice specification.

11. In case of any delay in the supply of required Stitching thread cones, alternative arrangement will be done for arranging the same and the additional expenses incurred towards the same will be recovered from your subsequent bills. Also suitable penalty as levied by the Management will be fined in case our production process gets affected due to lack of stitching threads.

12. The undersigned reserves the right to accept your offer partly/or in full or to reject without giving any explanation.

13. Incase of any dispute the Registrar of Co-operative Societies of Kerala State shall be the sole arbitrator as per the provisions of Kerala Co-operative Societies Act 1969. Any legal disputes raised shall be under Palakkad jurisdiction.
