Kerala Co-operative Milk Marketing Federation Ltd., Central Products Dairy, Punnapra P.O, Alappuzha invites competitive quotations from authorized venders for supply of 50 Nos. of 20 KG Cast Iron Hexagonal Shape Weights along with Stamping certificate by Legal Metrology Department of Kerala state at Central Products Dairy, Punnapra P.O, Alappuzha subject to the following terms and conditions.

1. SCOPE OF WORK:

Supply of 20 Kg standard weights (50 Nos) at Central Products Dairy, Punnapra P.O, Alappuzha.

2. TERMS AND CONDITIONS:

1. The material of the supplied weights shall be of cast iron and in line with IS 1056: 2004 standard.
2. Detailed technical specification of Cast Iron weights must be submitted before supply of the items. Manufacturer's test certificates shall be required for all supply items.
3. The weights shall be supplied in the denomination of 20 Kg each.
4. Total weight to be supplied is 1 Metric Ton. Therefore, the number of 20 kg weights to be supplied shall be 50 nos.
5. All the supplied weights are to be stamped by the department of Legal Metrology (Weights & Measure Department of Kerala Govt) & the calibration certificate is to be provided along with the material supply with a validity of minimum Two year.
6. Submission of stamping fees to W&M department is in scope of vendor.
7. Payment will be released only after getting the certificate from W&M department, and successful supply of material.
8. Any weight found without the marking of Legal Metrology Department would be rejected & the vendor has to provide the acceptable replacement for the same at his own risk & cost.
9. The vendor should have appropriate approvals required for the sale of the standard weights from the competent authorities & the vendor shall submit all such necessary documents along with the supply of standard weights.
10. Rates are inclusive of all taxes (GST etc.), freight, stamping by Legal Metrology, packing & forwarding, loading & unloading etc.
11. You are required to make the supply on door delivery basis at our Central Products Dairy, Punnapra P.O, Alappuzha.
12. The warranty of the supplied standard weights should be for a minimum period of one year from the date of supply.
13. The bidder shall quote the rates in the schedule of quantities attached with the tender document only. The bids shall be submitted after signing at the bottom of every page of tender document.

3. VALIDITY:

The offers submitted by the quotationer shall remain valid for acceptance for a period of 60 days from the date of opening.

4. PERIOD OF COMPLETION:

At the items specified in the scope of supply should be completed in all respects within 20 days from the date of receipt of supply order. However, the quotationer after examining the scope of supply and site conditions can specify in the offer the shortest period by which he will complete the supply of items in all respects.

5. SUBMISSION OF BILLS AND PAYMENT:

1. Bills shall be prepared in duplicate in the name of the **Kerala Co-Operative Milk Marketing Federation Ltd, Central Products Dairy, Punnapra P.O, Alappuzha GST: 32AAAK5375M4ZD** and shall be submitted along with the copy of the GST registration, PAN card to the Engineer for necessary certification and recommendation for payment.
2. Payment will be released within 15 days after receipt of items in good condition with stamping certificate from Legal Metrology, Kerala.

6. SUBMISSION OF QUOTATIONS AND OPENING:

1. The offer must be submitted in original in a sealed cover super scribing the name of the work, due date and time of opening.
2. Bidder should attach this tender document with rates written in the annexure attached along with this tender document, after signing at the bottom of each page of tender document as a token of acceptance of the terms and conditions and specification. The offers submitted in any other formats will not be accepted.
3. The offers complete in all respects should reach this office on or before 1 PM on 20/06/2025 and the same shall be opened at 3 PM on 20/06/2025 in the presence of interested quotationer or their authorized representatives.
4. The bids received after the tender submission date and time will not be accepted. Dairy will not be responsible for any delay in receiving the bids sent through post/courier.

7. GUARANTEE:

1. The supplier shall provide warranty for the items supplied in part or full if found defective due to bad workmanship or substandard materials within 12 months from the date of supply in dairy. The entire expenditure towards replacement / repair shall be borne by the supplier.
