- 3. Seasonal discounts if any offered shall be specifically mentioned in your quotation.
- 4. The uniform clothes shall be cut and supplied as per the exact measurements indicated under the "Supply Specification" column of the table above.

- 5. The party shall mention the brand name and composition of the uniform clothes.
- 6. The price quotation shall be supported with sample (of size 7.5 cm x 7.5 cm) for each item quoted.
- 7. The successful bidder shall supply the entire items within 15 days of receipt of the purchase order or the PO will be cancelled.
- 8. 80% payment against original invoice will be released within 10 days of invoice date and the balance 20% will be released only after complete distribution and quality confirmation from our end (but not later than one month of supply).
