SUBJECT: SUPPLY CUM LAYING OF RS485 DATA CABLE ALONG WITH POWER CABLE AND FOR INSTALLING SILO RADAR LEVEL SENSOR – reg.

Sealed price quotations are invited from experienced electrical contractors for supply and laying of shielded cable and for mounting of Radar Level Sensor on the silo roof at Milma Cattle Feed Plant, Malampuzha.

SCOPE OF WORK

Supply and laying of shielded power cable along with RS485 data cable through 20mm PVC /25 mm GI conduit /building walls /building surfaces/cable trenches /cable trays etc. and Fixing Five beam 3D Radar Level Sensor on the silo roof.

The detailed description of work and the related materials required are as listed in **ANNEXURE – 1** enclosed herewith.

GENERAL TERMS & CONDITIONS

- 1. Applicable statutory deductions like GST, income tax, sales tax, EPF/ESI, Work contract tax, etc. shall be effected while settling bills. The contractors must remit GST for the work and ESI/EPF for their employees. Also the contractor shall produce proof of remittance (Challan) along with bills to avoid the EPF/ESI cutting while submitting the bills and for considering release of payment. Bills without the ESI/EPF remittance proof will be settled only after cutting the statutory ESI/EPF from the bills.
- 2. All essential materials required for the work shall be brought to the site before commencing the work. The materials/tools & tackles brought inside our plant shall be properly listed and submitted to our Engineers for verification before in & out.

- 3. The supply order materials shall be inspected by our Engineers before acceptance for the said work. The materials shall be of our approved make as per the schedule of work order.
- 4. Each item of work as per work order shall be approved by our Engineers prior to the commencement of next work.
- 5. The contractor shall arrange for all compliance to the ESI/PF rules in force. Cattle Feed Plant shall not be liable for any benefits/compensation to the workers engaged by the contractor, in the event of accidents/mishaps etc. during execution of work. The contractor shall provide suitable safety measures to their workmen at the work spot inside our plant. The contractor or his workmen shall not interfere in any activity of the Plant and/or cause any damages to buildings/property. The entry of all such workmen will be on the basis of gate pass, which will have to be arranged by the Contractor prior to starting the work. In the event of any damage to Milma Cattle Feed Plant's property, due to the Contractor, the Contractor alone shall be liable.
- 6. Statutory deductions related to Income tax, ESI, EPF and other applicable statutory deductions will be effected while settling bills.
- 7. The plant day to day activities shall not be affected during the course of work.
- 8. The work found inferior in quality/bad workmanship shall be redone at contractor's risk and cost.

SPECIFIC TERMS & CONDITIONS:

- 1. The Contractor shall provide all the materials required for the works. The Contractor shall supply tools and tackles required for the works. Nothing will be arranged from our end.
- 2. All prices must be quoted as for site basis. The price shall include labour charges, statutory deductions, all taxes and duties, freight, packing, forwarding transit risk, loading etc. for the safe delivery of the items required for the job order and nothing extra will be paid on this account at later stage for any reason.
- 3. The offer shall be valid for 2 months for acceptance from the date of your offer.
- 4. The entire works shall be completed within 15 days from the date receipt of the work order.
- 5. All the works shall be carried out as per the directions and supervision of our plant Engineer.
- 6. The Contractor shall guarantee to rectify defects if any noticed in works due to bad workmanship at free of cost.
- 7. All safety measures (like safety belts, scaffolding's etc.) related to the job order shall be arranged by the Contractor. Work permit shall be taken by the

- Contractor before the commencement of work. All risk shall be covered by Contractor as per norms.
- 8. **Payment terms:** 100% payment will be released on satisfactory completion of scheduled supply & works.

- 9. **Penalty Clause:** In the case of the assigned job order being not executed and completed within the stipulated time period of 15 days, a penalty @1% of the total quoted value will be deducted for every day of so delayed.
