Functional requirements


These trays can be suitable for withstand temperature up to 130  $^{\circ}$ C and have capacity to carry minimum 50 Kg load.

## **Design Requirements**

Thickness: Thickness of the sheet should be 1.6 mm.

Material: The sheet should be of SS 304 or equivalent quality material.

#### Dimension:



The diameter of the punch hole is –  $\emptyset12$  mm and the distance between each hole should be 4
