"Enquiry for the purchase of 1 lakh numbers of laminated packing pouches for packing our Milmamin cattle mineral supplement"

We the Cattle Feed Plant under KCMMF Limited (MILMA) at Malampuzha, Palakkad is producing a cattle mineral mixture supplement called Milmamin. The 1 kg product is being packed with double packing of using 55 microns thickness plain opaque polythene covers for the inner packing and a two layered laminated 100 microns thickness pouches with printed pre-designed art work for the outer packing.

We now plan to purchase approximately 1 lakh numbers of printed laminated pouches from October 2021 to March 2022 @ 50000 numbers of printed laminated pouches for every three months period till March 2022. Hence sealed quotations are invited for the supply of printed laminated pouches as per the below given specifications, terms and conditions etc.

SPECIFICATIONS, TERMS AND CONDITIONS

Specifications

- 1 kg packing capacity for packing a fine powder material
- TWO LAYER LDPE LAMINATED, Total 100 MICRONS Thickness
- LENGTH: 320mm x WIDTH: 220mm
- BAND SEAL 55mm with D-Punch at the top
- Seal 10mm on both sides with provision for bottom sealing
- Printing in six colors as per our design

Terms & conditions

- 1) Price Basis: All prices must be quoted FOR factory basis including all taxes and duties, freight, packing, forwarding, transit insurance, loading etc. for safe delivery of the item at our Plant and nothing extra will be paid on this account.

- 2) Validity: The offer shall be valid for **ONE YEAR** for acceptance from the date of your offer as we may be increasing the quantity according to the demand. The rate quoted shall be the same throughout the order period.
- 3) Guarantee: The pouches supplied should be guaranteed for the total quantity and quality. If pouches found damaged, bad quality, under size, erroneous printing will be summarily rejected. For rejection on the above ground the Federation shall not be held liable to pay damages. Shortages in the quantity shall be replaced.
- 4) Payment: 80% payment will be released on satisfactory receipt of items at our site and balance within one month period.
- 5) In case supply is not completed within the stipulated period, liquidated damage @ 1% will be charged per week for the items so delayed subject to a maximum of 10% of the total value. After which the purchase order will be cancelled.
- 6) One number of any sample pouch of 100 Microns thickness shall be sent along with the offer showing your identity printed / marked on the pouches for identification.
- 7) Minimum order quantity per spell shall be mentioned in your offer.
- 8) We already have the Electronic Cylinder with the approved design for printing and hence no need for making the printing cylinder.
- 9) Minimum period for delivery after getting the confirmed order shall be specified.
- 10) Quotation submission closing date - 11.10.2021 till 5 PM
Date & Time of quotation opening - 12.10.2021 @ 11 AM
